2. Include an official transcript showing the awarding of your bachelor's degree.
3. A complete application must include the completed application, fee, copy of Iowa nursing license, bachelor's degree transcripts, and fingerprint cards.
4. Enclose an \$85 nonrefundable licensure fee and remit check or money order made payable to the Board of Educational Examiners, Licensure, Grimes State Office Building, 400 E. 14th St., Des Moines, IA 50319-0147.
5. Complete the fingerprint packet information. Enclose the \$65 fee. (*You may combine the \$85 and \$65 fees and send a single check/money order for \$150.*)
6. Please allow 6 to 8 weeks to process.

Name changes require a photocopy of official legal documentation. **ALL FEES ARE NONREFUNDABLE. Incomplete applications will be void after 45 days.**
